Executive Director said the certificate of authority is included in the agenda.

The Committee agreed to use a consent agenda structure for all future Fund agendas.

## **FINANCES**

#### PRO FORMA REPORTS

Executive Director reviewed the Financial Fast Track for SNJHIF which illustrated a gain of 1 million in November. He said \$5.4 million was transferred into the Coastal Fund to pay claims and allow the fund to operate on its own.

**RATIFICATION OF 2016 BUDGET -** In November 2015, the Southern Regional Employee Benefits Fund adopted the 2016 Coastal Budget at the recommendation of the Coastal Sub Committee. Now that the Fund is its own entity, the Executive Committee should formally adopt the budget, as well. The Budget and Assessments are included in the agenda.

Executive Director said the 2016 budget should be formally ratified by the executive committee. The current rates are in place and will not be changing. There is an average increase of 2.9%. In response to Chair Mercoli, Executive Director said the previous years should be closed out by June 2016. If the IBNR calculation is underrated, then money could be released earlier.

**TRANSFER RESOLUTION -** Enclosed is a copy of the Southern HIF Resolution 25-15 allowing for the closed years and current year owned surplus and cash from the SNJHIF to the new Schools Fund and the Southern Coastal HIF. The Resolution was unanimously passed by the Executive Committee at their November meeting and the transactions were made prior to January 1.

Executive Director said Bowman & Company will be doing an audit of the transfers and that should be ready in the next 4-6 weeks.

#### **ADMINISTRATION**

**ORGANIZATIONAL RESOLUTIONS -** A consent agenda has been included with the necessary resolutions for the Fund to operate for the year. Executive Director said the Cash Management plan list the depositories to which the Treasurers have put an aggressive investment plan in effect.

It was decided that Commissioner Harbinson will serve as the MRHIF Fund Commissioner and Chair Mercoli will serve as the MRHIF Alternate

MUNICIPAL REINSURANCE HEALTH INSURANCE FUND - The Municipal Reinsurance Health Insurance Fund has met on December 9, 2015 to adopt the 2015 budget in the amount of \$9,625,083, which was passed unanimously. Coastal's annual assessment is \$2,019,192. In addition, the Committee unanimously accepted the membership of the Southern Coastal HIF and will welcome the new representative at the January reorganization meeting on February 10. A report of the meeting is included in Appendix II.

Executive Director reviewed the MRHIF report that was included in Appendix II.

**CLAIMS INFORMATION** - The comparison of the Aetna results for 12/1/14 to 11/30/15 against the prior 12 months is favorable.

- ➤ The number of employees covered is up to 8.4% while paid claims are up only 4%.
- ➤ Paid claims per members is down 2.6%.
- ➤ In patient claims are down 8.9%, while admits are down 14.9%.

- > ER visits are down 6.1%.
- ➤ High dollar claims while up by 4% are down for amount paid by 5%.
- ➤ Coastal in network utilization is at 93% which is 1% better than the Aetna book of business of 92%.
- > ER utilization for Coastal for ER is 10% while Aetna book of business is 5%.
- ➤ ER costs is up 26.9% even though visits are down 6.1%.

Fund Coordinator thanked everyone for their support. Fund Coordinator reviewed the claims report and said while enrollment is up, claims are down. ER visits are down from years prior, but still above the Aetna book of business. He encouraged urgent care usage. The City of Brigantine will be joining the fund on 3/1/16 and West Cape May joined on 12/1/15. Low cost plan options have been successful and recommendations have been made to the entities including rx and dental.

Ms. Murray said open enrollment will be in April or May for the 7/1 renewals. Fund Coordinator said wellness grant applications are being accepted. In response to Chair Mercoli, Ms. Murray said formal applications can be sent out. Fund Coordinator also advised that the Fund website is up and running and a snow plan can be put in effect for future meetings.

**TREASURER** - Fund Treasurer introduced himself and the Deputy Treasurers and thanked the Fund for appointment. Deputy Treasurer reviewed the January 2016 Bills List that was included in the consent agenda. In response to Chair Mercoli, Deputy Treasurer said there will be more reports after the SNJHIF break, 4.2 million has been invested already for Coastal.

**FUND ATTORNEY-** Fund attorney thanks for the appointment. He said the Cadillac Tax has been postponed until 2020. He said this tax does not apply multiemployer plans. Although the Fund is not categorized as a multiemployer plan, it follows similar characteristics and may be worth pursuing to be exempt from the tax.

**AETNA-** Chair Mercoli reviewed the monthly and large claims reports. Fund Commissioner said it would be helpful to have an Aetna representative at the meetings going forward. In response to Chair Mercoli, Executive Director said it would not be necessary to have Express Scripts or Delta Dental at the meetings since the population with those carriers is low.

**OLD BUSINESS**: None

**NEW BUSINESS**: Chair Mercoli thanked the Committee for attending the innaugraual meeting. He said the Fund is currently in the green. The claims and data matured and premiums became more in line as the group aged. The positive aspect for a member to be in a pool is that a member will not get a high rate increase for one or two bad years. He said he is hoping for a successful year.
