EXECUTIVE DIRECTOR'S REPORT

FINANCIAL FAST TRACK - AS OF MARCH 31, 2019

Ms. Koval said the Fund made just under \$1 million for the month of March. She said the dividend will be reflected in the next fast track.

Ms. Koval said a draft of the Annual Financial Audit for the period ending December 31, 2018 is included with the agenda. She said Mr. Miles and Mr. Skalkowski from Bowman & Company are in attendance to review the draft Audit.

Mr. Miles reviewed the 2018 draft Audit. He said there are no findings or recommendations at this time nor do they anticipate any.

Included in consent is a ratification of this decision and an updated illustration of shares. In response to Commissioner Mercoli, Ms. Koval said this dividend is not reflected in the Audit.

BENEFIT EXPRESS UPDATE

Ms. Murray said Benefit Express will be changing to a new COBRA and retiree billing system by the end of the May. This change will impact any member currently being direct billed for COBRA, Dep31 or retiree premiums by Benefit Express. The new system will offer additional payment

options for members to pay their monthly premiums. Currently, the only form of payment they accept is a personal check however once the new system is implemented, members will be able to pay online, send in a check, or set up an ACH payment. Benefit Express will be sent out notices in mid-May to all COBRA and retiree members advising them of the change, new payment coupons will also be included as the payment address is also being updated.

EXPRESS SCRIPTS (ESI) UPDATES - For Groups with Rx in the HIF only 2019 Formulary Update:

Ms. Murray said ESI has announced that the National Preferred Formulary Guide (NPF), which the Coastal HIF utilizes, will be updated. Beginning 7/1/2019, the new Express Scripts formulary will go into effect for Coastal HIF members. Copies of the National Preferred Formulary and Exclusion list are included in this report.

There are approximately 4 Coastal HIF members who will be impacted by the Formulary update. Member impact letters were mailed in early May.

SAVEONSP UPDATE

Ms. Murray said SaveonSP continues to monitor the specialty medication market and associated manufacturer copay assistance programs to align the program with the available copay manufacturer assistance funds to maximize your savings opportunity. With that, we are adding 10 new therapeutic classes, modifying certain copays and will be removing 6 medications. **Effective 7/1/2019**, the **SaveonSP program will cover 19 therapeutic classes and over 150 medications**. Please see the below drug list for the medications being added to the program

- **Addition:** There are 10 new therapeutic classes added to the list; SaveonSP Program now covers medication in 19 therapeutic classes. <u>Members impacted will receive a notification letter informing them their drug qualifies for a \$0 Copay.</u>
- **Removal:** There are 6 medications being removed from the program. *Communication Plan:* outbound phone calls will be made to all members on one of the below medications:

<u>Monthly Billing</u> -As a reminder, please be sure to check your monthly invoice for accuracy. If you find a discrepancy, please report it to the Coastal enrollment team. *The Fund's policy is to limit retro corrections, including terminations, to 60 days.* We have noticed an increase in requests for enrollment changes, billing changes, terminations and additions well past the 60 day time frame. Moving forward, it is of the utmost importance to review bills for rate and enrollment accuracy on a monthly basis. If there is an error, please bring it to the enrollment team's attention.

Mr. Cowan said as previously noted the current surplus is \$23,289,311. He said he received the April claims today and there will most likely be an additional surplus of about \$700,000 before any adjustments. He said the Fund continues to run well.

TREASURER - Deputy Treasurer reviewed the April and May 2019 Bills Lists and Treasurer's Report. Commissioner Mercoli said perhaps there is a different strategy that can be explored by the Finance Committee for investing funds rather than locking money up in 12 month cd's.

FUND ATTORNEY - Fund Attorney said generally speaking they are doing a lot of document review and preparation. He said things are heading in the right direction.

AMERIHEALTH ADMINISTRATORS - Ms. Strain reviewed the claims for April 2019. She said there were 3 large claims over \$50,000 and for the year the paid medical claims is a little over \$ 7 million. In response to Commissioner Mercoli, Ms. Strain said she agrees there is a difference in the dashboard numbers for AHA vs. Aetna. Ms. Strain said this is one of their initiatives to bring the numbers closer in line to their competitors.

AETNA - Mr. Rodrigues reviewed the paid claims through March 2019. He said the total paid claims for March is just under \$5 million. He said there were 7 claimants over \$50,000 for the month of March. He reviewed the dashboard and noted that they are currently meeting all performance metrics. In response to Commissioner Mercoli, Ms. Koval said all Funds report on claims over \$50,000 however that can be adjusted in necessary.
