SOUTHERN COASTAL REGIONAL EMPLOYEE BENEFITS FUND INTRODUCTION OF THE 2017 PROPOSED BUDGET AND CLOSED YEARS FUND RELEASE

WHEREAS, The Southern Coastal Regional Employee Benefits Fund is required under State regulation to adopt an annual budget in accordance with the Fiscal Affairs Law; and

WHEREAS, the Executive Committee met on October 3, 2016 in Public Session to introduce the proposed budget for 2017 Fund Year; and

BE IT FURTHER RESOLVED that a hearing on this 2017 budget in the amount of \$56,652,355 shall be held at the Fund's regularly scheduled and advertised meeting of November 3, 2016 to be held at the Eastlyn Golf Course, Vineland, NJ at 12 noon. This 2017 budget shall be considered for adoption at a second reading at that time and after the completion of a public hearing.

BE IT FURTHER RESOLVED that included in this budget is a dividend of \$1,200,318 from the closed years account to be declared; of which will be distributed to eligible members. Eligible members no longer in the Fund will receive their portion in the form of a check.

BE IT FURTHER RESOLVED that copies of this resolution shall be sent to each Fund Commissioner, Risk Manager, and Governing Body, the New Jersey Department of Banking and Insurance, and the New Jersey Department of Community Affairs.
