



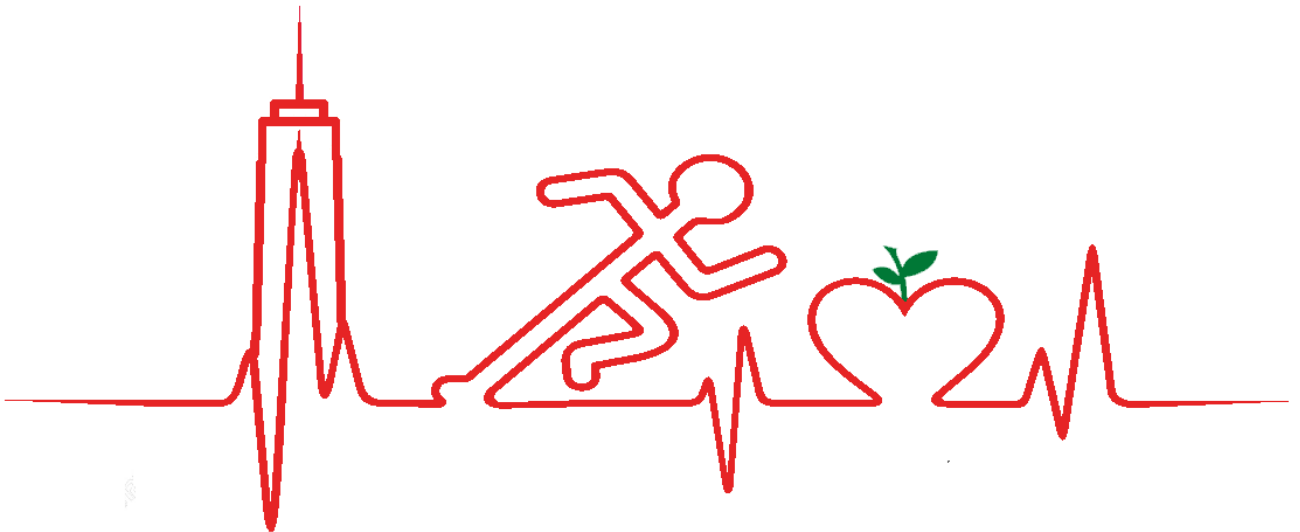

One Time Testing

Active COVID-19 Nasal Swab Tests (RT-PCR)

Results in 2 to 3 days

RT-PCR: testing includes everything needed to administer sample onsite. Tests are sent to laboratory for analysis. Results are retrieved from lab's portal.

Test Type: Nasal Swab

Minimum: 50 tests per clinic

All tests will be analyzed in one of the laboratories that we partner with. The results will be emailed to participants in order to access their results.
